PUBLICITY OPPORTUNITY FOR ENTRANTS

A publicity campaign will accompany the *Art Unlimited* event. Artists who submit artist statements (up to 300 words), images in jpeg format on disc of their work and a close-up shot of themselves in their work environment will be considered for inclusion in the publicity campaign. Statements and images can be emailed to media@artunlimitednsw.com.au. They must be received by 19 March 2012 to be considered for inclusion.

CONDITIONS OF ENTRY

1. Artists are invited to enter the 2012 *Art Unlimited* competition by posting a completed entry form, together with a \$10 entry fee for each work entered, to the above mentioned postal address.

Cheques or money orders must be made payable to *Art Unlimited*. Late entries will not be accepted.

2. Works entered must meet the following criteria:

- 1) Hanging art – two (2) dimensional in any media and READY TO HANG securely to professional standards.
- 2) Photography – must be standard photographic media, either professionally framed or stretched and in all cases READY TO HANG securely to professional standards.
- 3) Ceramic piece – functional or decorative ceramic work.

3. Members of the committee and judging panel may exhibit works for sale in the *Art Unlimited* exhibition but cannot take part in the *Art Unlimited* competition and will be excluded from the judging process.

4. Artists may enter multiple individual artworks. The same entry procedure and a separate \$10 entry fee applies to each artwork submitted.

5. Any publicity material submitted by the artist to be considered for inclusion in the publicity campaign must be clearly marked with contact details of the artist including the name of the artist and the title of the work(s). Artist profiles can also be emailed to media@artunlimitednsw.com.au. The profile is for promotional purposes only and will not form any part of the judging process.

6. Any material submitted for publicity purposes may be reproduced at the discretion of the committee (including on the *Art Unlimited* website) for promotional purposes and at no cost to the committee.

7. If the artwork is for sale, the sale price (including commission) must be included on the entry form and on the back of the work.

8. In the event that the number of entries exceeds the amount of display space available for the competition, or the works are deemed unsuitable or do not meet the competition criteria, the independent selection panel reserves the right to withdraw artworks from the competition.

9. The decision of the judging panel is final and no correspondence or discussion regarding its decision will be entered into. By participating in the competition, participants agree to be bound by the decisions of the competition committee and judging panel. It is a condition of entry that all rules are accepted as final and that the competitor agrees to abide by these rules.

10. Entry fees paid will not be refunded under any circumstances. Costs relating to the return of artwork(s) will be the sole responsibility of the artist.

11. The panel of judges will award \$3000 in prize money to the entrant awarded 1st place in each of the following categories:

- 1) hanging art, 2) photography 3) ceramics.

12. The closing date for entry forms is Friday, 20 April 2012. Entry forms will not be accepted beyond this date.

13. The date for the postal delivery of Artworks is no earlier than Thursday, 10 May 2012. Artworks must be personally delivered ONLY on Saturday, 12 May (9am-3pm) & Sunday, 13 May 2012 (9am-3pm) to:

14. Artworks received after this date will be excluded from the *Art Unlimited* event.

15. *Art Unlimited* will receive a 25% commission of all works sold throughout the duration of the *Art Unlimited* event.

16. Delivery and return transport arrangements to and from the *Art Unlimited* event must be organised and paid for by the artist.

17. All artworks must be clearly marked on the back with the artist's name, address, title and date of work. If your work is for sale, also include the sale price on the back (including gallery commission). If the artist is registered for GST, the sale price must include GST. The sale price will not be changed.

18. All delivered artworks must be adequately packaged and marked with the artist's name and address in marking pen. Artworks that arrive damaged will not be exhibited. The artist will be notified. All returned artworks will be wrapped in the same material they were delivered in.

19. An artwork must be presentable for exhibition according to the Terms and Conditions. Any artworks that are not ready to hang for display will not be included in the *Art Unlimited* event.

20. The cost of transit insurance must be met by the artist. The *Art Unlimited* committee accepts no responsibility/liability for any damage incurred to the artworks.

21. Following the *Art Unlimited* event all artworks must be collected/returned by Sunday, 20 May (4pm-7pm) 2012 or Monday, 21 May (9am-3pm) 2012. *Art Unlimited* will not have insurance or holding capacity beyond these dates.

22. Entries will be covered by *Art Unlimited* insurance for the duration of the Dunedoo event only (from 9am Thursday, 10 May 2012).

23. Entry is restricted to artists aged 18 years and over.

24. Entry for Orana Arts Aboriginal Artist Prize is restricted to Aboriginal and Torres Strait Island artists.
